I am an herbalist... Herbal medicine is the form of medicine I chose to use; just like the form of religion I might chose. Don't I have the right to decide what substance to put in the bodies of my children? Of myself? I thought we were Americans; where the Constitution protected our right to chose? Who is in charge of my health?

My answer is ME! I get to decide! My decision is based on wisdom; I should have freedom to access those who have that knowledge. I don't want to be prejudiced either. I just want what's best for my family, clients and me. We have a wonderful joke among herbalists, "Don't take me to an herbalist if I get hit by a truck, take me to the emergency room". Maybe I won't fill the prescriptions, and I've been known to saw a cast off so to put an herbal poultice on a bone, but I'm not so blinded by my love of herbs that I don't have the common sense to seek appropriate medical attention when needed. Modern medicine is *one* option. I personally think it wise to use it as the last resort in most cases, because of the numerous negative side effects frequently involved with this choice in medicine style. Either way, it's still me who decides. Or is it?

This issue of who is in charge of my health goes back to a self-responsibility, a belief that the body heals itself. Real whole plants are much more able to work with the genetic/evolutionary coding of our bodies, we were made to work with the energetic patterns given off by the plants when we ingest them. They help our cells; tissues and the energetic blueprint of our bodies remember how to be in balance once again. I don't believe one can get all that from a pill made in a chemical laboratory.

I thought to myself, I pay this nurses salary, just like all the other taxpayers, why is my form of medicine discriminated against? Lack of education! I offered to do a free presentation on herbal medicine for the school district nurses; she never took me up on it.

I try to walk softly in this world; the plants are under my feet. I value my freedom to seek health and healing. The laws as they are currently written make what I do everyday illegal. I thought if I was careful, honest and appropriate for my education level, that it would be okay. I was wrong, our current laws make it illegal for individuals to access the knowledge I offer. Anyone can be taken to court, accused of practicing medicine without a license for suggesting anything that is healing, this would include peppermint tea for a stomachache or Peter Rabbit's mother fo

giving him chamomile tea to get him to sleep.

I' m still an Herbalist. Now, in this world where antibiotics and chemical medicine' effectiveness is beginning to fade and it' s safety publicly questioned, we need to stand up for our birthrights; to be able to use the plants of this earth, the wisdom of the weeds that grow in your own back yard, we need their medicine and spirit energy to survive. Think about it, we can' t even breathe without them; they are spirit' s gift to you for being a member of planet earth.

Interesting Health News: Hair dye may raise cancer risk: Study

WASHINGTON: Women who have been colouring their hair for 24 years or more have a higher risk of developing a cancer called non-Hodgkin lymphoma, US researchers reported on Friday.

They said that their study of 1,300 women could help explain a mysterious rise in the number of cases of the cancer that affected the lymphatic system. Writing in the American Journal of Epidemiology, they said that women who dyed their hair starting before 1980 were one-third more likely to develop non-Hodgkin lymphoma, or NHL, and those who used the darkest dyes for more than 25 years were twice as likely to develop the cancer. "Women who used darker permanent hair colouring products for more than 25 years showed the highest increased risk," Tongzhang Zheng, associate professor of epidemiology and environmental health at Yale School of Medicine, said in a statement. Cancer experts noted that a person' s absolute risk of developing lymphoma was very low, so doubling that risk still meant a woman who dyed her hair was very unlikely to develop lymphoma. Non-Hodgkin lymphoma will affect an estimated 54,000 Americans this year and will kill 19,000, according to the American Cancer Society. It affects slightly more men than women. The incidence of NHL has doubled since the mid-1970s and no one knows why. Experts suspect exposure to chemicals can be a factor. The lymphatic system is part of the immune system, so people with immune weaknesses are at special risk â•" notably AIDS and organ transplant patients.
